We are currently in a very dire situation in regards to our public water system in Mathiston. I recently learned that only one of our two water wells that supply the town with water is in working condition. Basically, if something happens to the one working well, pumps, etc., the Town of Mathiston and surrounding areas would immediately be in a public health crisis. We've heard all the clichés..."hanging by a thread," "ticking time bomb," amongst others. These would adequately describe our current water situation. I'm concerned not only for myself and my family, but also for the many people and businesses that are the lifeblood of our small rural town. I own the Mathiston Apartments L.P. apartment complex in town, which houses 24 elderly and disabled tenants, many of which don't know about or understand the fragility of our water system. I have a deep concern for their well-being, a lot of which are shut-in and in declining health. Something we all take for granted, clean water, could be taken from us in an instant. Numerous businesses would also cease to function in our area if our only working water well faltered. We do not have the resources of a major metropolitan area, but need clean, running water just the same. Please accept this letter as our plea for help on the repair of this dilapidated water system that has limped by until it has seemingly reached its limit. As an American and Mathistonian, I feel we should all have access to clean water and I've never been as concerned as I am now for our little town. We are truly on the brink of the unthinkable and my prayer is that whoever reads this letter, will sense the sincerity and desperation of the contents within.

I am Mayor Jimmy Carden of Mathiston, Mississippi. My letter today is in response to our current water crisis in Mathiston. Our system is made up of two elevated water tanks and two deep wells. Currently one of our wells is inoperable and is not able to be repaired. This has caused us to have no other choice but to declare a State of Emergency for the Town. We serve about 550 meters in the city limits and we sell water to a neighboring community system with 100 meters.

We are not financially able to afford even the band-aid solution much less funding for a new well at this time. Not to mention being able to address our full need of two wells because our other well is over 40 years old. We also have one of our elevated tanks that will lose its acceptable status in two years and due to its lead paint content will have to go out of service.

We are asking for your help in this matter and trust that you will certainly hear our cry and do all that is possible to help meet the needs of a small rural town of 1000 people in North East Mississippi.

All of your help will be greatly appreciated in this very serious situation.
