On behalf of the Pontotoc County Chamber of Commerce and Main Street Association, I am writing in reference to the need for a relocation of a fire station for the City of Pontotoc Fire Department. While the current fire station has served its purpose through the years, it no longer functions as efficiently as needed due to the congestion of the area where it is located. The property the fire station sits on joins Pontotoc Junior High, and the high school is located across the street. When these buildings were constructed, a large majority of students rode the bus to and from school. Many students are now picked up by parents, or the students drive to school. Due to all of these vehicles, a congestion is created every morning and afternoon. While the City of Pontotoc Fire Department has adjusted to this situation, it is less than ideal. This fire department is also connected the city hall. There is a need for room on the interior of the building for the day-to-day operations of the city hall, and there is also a need for more parking spaces for those conducting business at the city hall. A large portion of the space in front of the fire department/city hall cannot be utilized for parking due to not being able to park in front of the fire trucks. Moving the fire department would help alleviate several problems for the city hall.

Chief Lance Martin has worked diligently and efficiently in creating a plan for a new fire station. Due to his forward thinking, the proposed fire department should effectively serve Pontotoc for many years to come. Chief Martin has navigated the grant process many times during his tenure. If awarded this grant, I have every confidence in the abilities of Chief Martin to effectively see this project through from start to finish. He also has a strong support staff who would be able to assist him if needed.

In closing, I might add that Pontotoc was one of the few areas in North Mississippi to see an increase in the population during the last conducted census. Pontotoc is growing, and we need to prepare for this continued growth. If awarded this grant for a new fire station, we are moving a step closer to preparing for the future.

I currently serve as Chancery Clerk and County Administrator for Pontotoc County, Mississippi, and thereby coordinate services frequently with the Pontotoc Fire Department. Our firemen consistently work hard to keep our town and county safe, however the current location of the downtown station on Main Street strains local services from dispatching efficiently and constitutes a major safety concern for local residents due to high traffic volumes consistent with downtown commerce and the City school's daily operations all within the same vicinity.

Dear Committee Members:

I currently serve as Fire Chief for the City of Pontotoc, MS. We have two stations strategically located to serve our community with both full and volunteer staff. We serve approximately 6,400 residents inside the municipal limits of Pontotoc City, and we also have a Pontotoc County response district that extends approximately a 5-mile radius outside the Municipal limits. This county district has around 7,000 residents who are solely our responsibility. Additionally, we are the primary rescue services for entire Pontotoc County.

The downtown fire station (Station 1) is the base of all the above mentioned services provided. We currently share a building with City Hall and are directly across the street from Pontotoc High School and adjacent to Pontotoc Jr High campuses. Furthermore, the primary school athletic facilities for the school district is located behind the FD. As an additional complication, we have a crosswalk for Main Street (MS HWY 9) within 8 feet of our engine bays that has a constant flow of teacher and student foot traffic traveling between campuses during and after the school day.

While most crosswalks are at an intersection or have some other type of traffic control device to regulate movement, ours does not. During my tenure as Chief, I've watched the congestion of foot traffic, school traffic, and commercial traffic increase to the point of serious safety concerns for our students and residents from our emergency apparatus responding to and returning to quarters. It is often necessary for fire fighters or police officers to temporarily stop the flow of traffic in front of our station on a state highway so that we can leave or return to the station. This congestion greatly inhibits our response to calls where minutes and seconds can positively or negatively impact outcomes.

The safety of everyone is our highest priority. We consistently striving for lower response times to our city and county district territory but are hampered by variables that are outside our control. The relocation of Station 1 would not only enhance and lower response times to our most rural areas, but also alleviate the concerns of student and bus safety as they travel this route daily picking up and dropping students from campus to campus.

I've attached letters from community leaders, community organizations, and business owners who share our concern and support our attempt to relocate Station 1. While we are all committed to relocating Station to a more feasible location, the move will be quite a difficult task without financial assistance. We have already expended considerable effort to find an appropriate and central location for Station 1. The new location has received approval from the Mississippi State Rating Bureau and the Mississippi Insurance Commissioner's Office. It is only a few blocks off of Main Street and is close proximity to other city and community service providers. It will provide safety and assistance to the citizens and businesses of Pontotoc for decades to come. Further, the transition from the current location to the newly approved location will be an easy one for staff and our citizens. I humbly request your thorough consideration of our grant application. We would appreciate your assistance in funding this vital community project which can be summarized in one word: "SAFETY". The overarching goal is to make our Fire Department safer for our staff and for all those who we serve now and in the future. Thank you in advance for your time and consideration. I eagerly look forward to your response.
