

On behalf of the Choctaw County Emergency Management Agency, I am writing to express my support and confirm the extreme need for a new Fire station/EMT Station in the central part of our county. Having this facility near the Red Hills complex would serve multiple needs. It would be extremely beneficial to the health and safety of the people of Choctaw County to be able to dispatch emergency services from a centralized location.

Another advantage is that the proposed location would be close to three of our major industries in the county and to the Choctaw County EcoPlex. We have two power plants and a coal mine that collectively employ hundreds of people who are onsite all hours of the day. Efforts are ongoing to recruit more industries into our EcoPlex. Dear Representative Kelly,

I am fortunate enough to work in Choctaw County at Mississippi Lignite Mining Company outside of Ackerman. The 200-plus men and women who work at our Red Hills lignite mine are proud of the part they play in providing coal for electrical power in North Mississippi. But we are only one part of a complex of energy-related industries in the Red Hills complex. Southern Company's Red Hills Power Plant – for which we provide coal – and TVA's Ackerman Combined Cycle power plant also employ a large number of mostly local men and women.

I am proud, as I know they are at the power plants, of our commitment to safety and our decadeslong record of safe production. Part of that commitment is having a plan in place to respond to any emergency as quickly as possible. It is my understanding that Choctaw County is seeking to build a combined fire/EMT station adjacent to the Red Hills complex that would be able to respond quickly to an emergency at the power plants, the mine, and to the surrounding residents. Please allow this letter to convey my enthusiastic support for this venture. In an emergency, time is often of the essence. Having a fire and EMT station less than five minutes from three major industrial sites will provide a level of response that is sure to lessen the impact of an emergency we work hard never to experience. Further, I believe this facility will also be a selling point for other industries who may be considering locating at the Red Hills complex.

Thank you for taking my thoughts under advisement and for your assistance to Choctaw County as they seek funding for this important project.
